John Adair, Co-Lead Counsel Remarks

Thank you for taking the time to be here with us this evening, whether you are in person, joining us online or watching us on television. My name is John Adair, and I am one of the three Co-lead Counsel for the Commission.

Christine Mainville, Co-Lead Counsel Remarks (Delivered in French)

Kate McGrann, Co-lead Counsel Remarks

Thank you, John, Christine and good evening, everyone,

I am pleased to be here tonight to participate in this important meeting and to introduce you to the Honourable Justice William Hourigan.

Justice Hourigan was appointed Commissioner to lead this independent public inquiry on December 17, 2021.

Justice Hourigan has a distinguished 30-year career in the law:

- In private practice, Justice Hourigan specialized in complex commercial litigation;
- He was appointed to the Ontario Superior Court in 2009, where he served on the Board of Directors of the Ontario Superior Court Judges' Association; and
- In October of 2013, he was elevated to the Court of Appeal for Ontario.

The Commissioner will make recommendations in a final report that is expected to be delivered at the end of the Summer or in the Fall, to Ontario's Minister of Transportation, to help prevent these issues from happening again in future stages of this project and in other infrastructure projects in Ontario.

John, Christine, and I are very proud to work with him and to support this important public inquiry.

I would now like to turn it over to Commissioner Hourigan.
