## AFFIDAVIT OF SARAH MEAGHAN WRIGHT GILBERT

I, SARAH MEAGHAN WRIGHT GILBERT, of the City of Ottawa in the Province of Ontario, AFFIRM:

- 1. I am a Citizen Transit Commissioner and have been closely following the Ottawa Light Rail Transit Public Inquiry (the "OLRT Inquiry"). As such, I have personal knowledge of the matters to which I hereinafter depose except where I have stated my evidence to be on information and belief, in which case I have indicated the source of my information and my belief in its truth.
- I was appointed to the Transit Commission as a Citizen Commissioner on January 30, 2019. Attached hereto as Exhibit "A" to my Affidavit is a true copy of the relevant excerpts of the Minutes of the January 30, 2019 City Council Meeting.
- I signed my Declaration of office on February 6, 2019. For ten years prior to that, I had used public transit daily to go from my home in Orleans to my job as a federal public servant in downtown Ottawa and later at Tunney's Pasture. Attached hereto as Exhibit "B" to my Affidavit is a true copy of my Declaration of Office dated February 6, 2019.
- 4. I understood that Citizen Commissioners were appointed to provide a transit user's perspective while providing oversight and direction to OC Transpo. I have not only brought my perspective as a daily transit user, but also as a stakeholder engagement and communications professional.
- 5. On June 30, 2022, Ottawa Mayor Jim Watson gave evidence before the OLRT Inquiry in which he impugned my professionalism and made false allegations against me. During his testimony in response to Commission Counsel John Adair's questions regarding a WhatsApp discussion pertaining to me, Mr. Watson stated:

"I can tell you – I can put that in the context where on numerous occasions when this particular commissioner sent out tweets with false information that caused tremendous grief in the community and a number of personal attacks on the integrity of Mr. Manconi and members of his staff.. she was sending out completely false information about a stalled train that would cause people to panic...."

Attached hereto as **Exhibit "C"** to my Affidavit is a true copy of pages 193 to 194 of the OLRT Inquiry Hearing Transcript of Mr. Watson's testimony dated June 30, 2022.

- 6. I have reviewed every tweet, retweet, quote tweet and reply tweet I sent on Twitter between the dates of September 14, 2019 (public launch of the LRT Line 1) and October 26, 2019 (date of WhatsApp messages referred to in paragraph 5, above) and can confirm that none of my tweets were personal attacks on the integrity of Mr. Manconi or members of his staff. I was critical of OC Transpo as an organization and public institution, specifically with respect to their customer communications, but my criticisms never rose to the level of personal attacks.
- 7. I can also confirm that I never intentionally sent out false information.
- 8. During that period of time, OC Transpo was not communicating in a timely or effective way with its customers about the stopped trains and resulting delays. Due to the communications void from OC Transpo and the City of Ottawa, members of the public were sharing their observations with one another on social media in order to assist other passengers. I was inundated with tweets directed at me, informing me of delays, stalled trains, dangerous station conditions (such as slippery floors) and general customer dissatisfaction.
- 9. I attempted to help my fellow transit riders by re-tweeting as many of these tweets as I could. I can recall a handful of occasions when a tweet sent to me turned out to be inaccurate or out of date, such as a previously stalled train no longer being on the tracks. On those few occasions when inaccuracies were brought to my attention, I either put out a clarification or deleted the tweet.
- 10. I have reviewed the transcript of Mr. Watson's WhatsApp chats which was filed as an exhibit before the OLRT Inquiry. On October 25, 2019, Mr. Watson himself expressed frustration to Mr. Manconi regarding the shortcomings in OC Transpo's communication with its customers during the same period of time. Attached hereto as Exhibit "D" to my Affidavit is a true copy of p. 24 of OLRT Inquiry Exhibit 206, "Whats App Chat Log 16 July 2019 to 31 December 2019."
- 11. In his questioning of Mr. Watson on June 30, 2022, Commission Counsel John Adair put to him a portion of a WhatsApp message from Mr. Manconi wherein he referenced an interview I had given on local radio station, CFRA:

"Why isn't someone pulling that public commissioner off the air. She is live in CFRA. A call in asking people to complain about OC Transpo? She is destroying

us with misinformation. Destroying the brand and accusing us of distorting facts. Also talking about congestion. How is this appropriate or fair?"

Attached hereto as **Exhibit "E"** to my Affidavit is a true copy of page 192 of the OLRT Inquiry Hearing Transcript of Mr. Watson's testimony dated June 30, 2022.

- 12. The interview Mr. Manconi was referring to in his WhatsApp message took place on October 26, 2019. A recording of the interview is available at https://omny.fm/shows/580-cfra/hour-2-of-the-goods-for-october-26-2019?in\_playlist=580-cfra!the-goods-with-dahlia-kurtz (interview starts at13:55)
- 13. Listeners were invited to call in, or post on the station's social media channels, and share their biggest concerns with respect to the LRT, with the stated goal of providing me with information that I could share with OC Transpo at the next Transit Commission meeting. I have relistened to the audio of that interview multiple times in the course of preparing this Affidavit. To my knowledge, at no time during that interview did I offer misinformation, nor did I accuse OC Transpo of distorting facts. I did talk about my experiences as a daily transit user.
- 14. During the period of time between September 14, 2019 and October 5, 2019, the first three weeks of LRT service when parallel bus service was still in place, I received an unsolicited phone call on my personal cell phone from Mr. Manconi while I was packing up my things to leave my office for the day. In the course of that call, Mr. Manconi stated the following (paraphrased unless indicated with quotation marks):
  - (i) That my criticism of the public transit system was causing riders to lose faith in the system;
  - (ii) That OC Transpo employees were suffering from low morale as a result of my criticism and felt that I was "not on their side."
  - (iii) Mr. Manconi compared the situation to an Apple Inc. board member being critical of the new iPhone, causing the stock to tank;
  - (iv) Mr. Manconi stated that if I had issues while using the LRT, I should call him directly and not post on social media;
  - (v) Mr. Manconi also directly asked me to stop tweeting criticisms of OC Transpo communications or Line 1 of the LRT.

- 15. I found this call to be unnerving and inappropriate. Furthermore, while Mr. Manconi clearly had many issues with my use of social media to fill the communications void, at no time did he express to me that he felt I was spreading misinformation. Mr. Manconi confirmed that this call took place in an interview he gave the Ottawa Citizen which was published on February 15, 2020. Attached hereto as **Exhibit "F"** to my Affidavit is at true copy of the Ottawa Citizen article dated February 15, 2020.
- 16. In my review of the evidence proffered at the OLRT Inquiry I have learned of new ways in which Mr. Watson and others discussed ways to silence me and even possibly seek my removal as a Citizen Commissioner.
- 17. While Mr. Watson and others were not successful in having me removed from my duly appointed position, the WhatsApp messages and Mr. Watson's *viva voce* evidence before the OLRT Inquiry show that they have instead attempted to discredit me and cause me reputational harm by wrongly claiming that I spread false information and engaged in personal attacks.
- 18. I make this Affidavit for the purposes of clarifying the record before the OLRT Inquiry and for no improper purpose.

It's early Friday afternoon on a cold day in February and, once again, Sarah Wright-Gilbert's phone is blowing up.

STORY CONTINUES BELOW

One year into her volunteer role as a citizen transit commissioner, the 38-year-old has made herself an essential source of news and information about the city's fickle light rail system.



Today, the Confederation Line is having trouble navigating the winter weather: two trains have had to be towed. The episode follows a morning power outage that delayed some trains, and still more "switch issues."

Wright-Gilbert has taken to her preferred medium, Twitter, to update commuters on the unfolding situation and to express her dissatisfaction with the status quo.

"It's a snowy day (because Ottawa) and we yet again have switch issues and power failures — not to mention a complete lack of communication from OC Transpo. I'm so frustrated with our transit system."

Wright-Gilbert has used her platform as a commissioner — and the power of social media — to insert herself into the heart of the discussion about this city's LRT. She has repeatedly called out OC Transpo management for failing to provide timely information or a reliable service.

To transit riders, she has become a folk hero of sorts: a fulcrum for their exasperated calls for action.

To OC Transpo officials and some of her fellow board members, however, she has become something of a problem: a wild card who refuses to play by the house rules.

"I will play by the rules, but the actual rules — not the ones that are just made up because I'm not in your club," Wright-Gilbert insists in an interview.

"They attempted to control me," she adds. "But I don't know who they thought they were dealing with...I really don't know what they were thinking. It just pissed me off more."

'A lot of frustrations': Montreal is hoping to avoid Ottawa's LRT mess

Last fall, Wright-Gilbert says, she received a phone call from OC Transpo general manager John Manconi after posting to Twitter about the problems she had encountered on her daily commute between her home in Orléans and her job in Tunney's Pasture. It was during the first three weeks of LRT service when parallel bus service was still in place.

"It was a 10-minute conversation," she recalls, "mostly one-sided, where he equated what I was doing with a board member from Apple speaking out and tanking the stock.

"I said, 'The difference is you're not the CEO, this isn't Apple, and I don't work for you."

Invited to offer his version of their exchange, Manconi said it's his practice to call transit commissioners personally or to have a member of the senior management team contact them whenever he becomes aware they've raised concerns. "We have met with commissioner Wright-Gilbert to discuss with her comments and suggestions regarding the O-Train Line 1," he said.

The next attempts to bring Wright-Gilbert in line were entirely public.

In late October, transit commission chair Allan Hubley suggested in an open letter that Wright-Gilbert's request for an emergency meeting was "helping to destroy any remaining faith or confidence our ridership has in the system."

Weeks later, transit commission vice-chair Jean Cloutier denounced Wright-Gilbert's continued public criticism of the transit service. On Twitter, he called on her to work internally to fix the system rather

than issue what he called unproductive, unfair and inaccurate tweets. (Cloutier declined to be interviewed for this story.)

"You seem to believe," he told Wright-Gilbert on Twitter, "that Twitter and media appearances is (sic) a substitute for an actual phone call, an actual meeting, an actual discussion and an actual plan for improvement."

Coun. Jeff Leiper leapt to Wright-Gilbert's defence online, saying he valued her work: "She has demonstrated courage, empathy and persistence in a very challenging time that warrant celebration, not reproach," he posted.

For her part, Wright-Gilbert says it's not her job to be cheerleader for an underperforming system, but to speak for the city's commuters.

She uses Twitter, she says, to be transparent about that work and to report on her personal transit experience: "I'm a transit user. I don't lie. I don't spread propaganda. I report what I see. It's truth."

She has also reported on what she smells: sewage at Parliament Station. But even that led to headlines when one transit commissioner suggested that, as a woman, she was particularly sensitive to bad odours.

It has been that kind of year for the rookie transit commissioner: Controversy seems to follow her.

A civil servant, Wright-Gilbert sought out the citizen transit commissioner's job in an attempt to fill out her résumé with more volunteer work. She read about the initiative online and thought it was an interesting approach.

One of 92 applicants for the unelected post, she was among four people chosen by a panel of city councillors. "They knew exactly who they were getting," she insists. "I don't hide who I am."

Born in Oakville, Wright-Gilbert grew up mostly in Ottawa, where her father worked as an RCMP officer, and later, as a foreign affairs analyst. Her mother was a court reporter, and Wright-Gilbert did the same job for a few years at the Ottawa Courthouse until the domestic abuse trials began to wear her down.

She's a self-described speed-reader and "politics nerd" who has watched her favourite TV series, West Wing, a dozen times. "If Jed Bartlet ran today, I would vote for him," she says. "Or Josh Lyman."

She fosters rescue dogs, fundraises for animal rescue charities, advocates for the homeless, and speaks openly about how she's learned to deal with depression and anxiety.

A graduate of Carleton University's political science program, she also champions political involvement, particularly at the local level. "The decisions made at the municipal level touch your life most directly," she says.

Wright-Gilbert knows that some people think she's positioning herself to run in Cumberland Ward, where a byelection could be held if Coun. Stephen Blais succeeds in capturing the provincial seat for Orléans on Feb. 27. But she insists that politics is not on her immediate horizon — even though some people have already approached her about launching a candidacy.

"It's something I'm thinking about for 2022 or later," she says.

Wright-Gilbert works full-time as an engagement policy advisor on the cannabis file for Health Canada, and uses accrued overtime and vacation time to fulfill her duties as transit commissioner. (The position's only remuneration is a free transit pass.)

She had no idea, she says, how city politics worked when she attended her first meeting in January 2019.

That changed quickly when the oft-delayed LRT launched in September, and problems mounted alongside commuter angst. Those problems, she says, exposed divisions on the commission between

those who wanted to circle the wagons and defend the system, and those who wanted full transparency.

Wright-Gilbert says the commission, like council itself, is controlled by councillors allied to Mayor Jim Watson. "I'm slightly disappointed in how city hall operates," she says. "Part of my disillusionment was realizing what was really going on at city hall, discovering that it's true that there is a Watson club, or JW crew...I think it's really unfortunate: If your councillor is not in the crew, you kind of get screwed."

Wright-Gilbert keeps a list on her iPhone of everything that she wants to raise at the next transit commission meeting. This month, it includes questions about the odour at Rideau Station, water leaks, track vibrations, malfunctioning fare machines, and the "brake issues" raised by a British consultant in an interview with Coun. Carol Anne Meehan.

She intends to script her questions and followups to maximize her allotted time at the next commission meeting on Feb. 19.

"If I have been any sort of catalyst for people no longer accepting the status quo of crappy service from OC Transpo, then good. Good," she says. "It has made me slightly unpopular with some folks, but my only motivation is to improve public transit for everyone."
