Dear ExCo,

City wants a RTG & ExCo call this Friday. You should have received a forwarded meeting invite from me.

Matt and I met with John Manconi and team today to map out some key dates. Steve Kanellakos and John Manconi will want to hear from ExCo that we are all aligned. The dates are:

July 3 – 17 coupled LRV's ready.  
 July 7 – Alstom snags complete  
 July 8 – Thales safety certificate for v5.05 software in hand and upgraded s/w installed or being installed  
 July 9\*\* – RTG submits new Substantial Completion application and commits to a RSAD of 16 Aug  
 July 10 – FEDCO meeting (City will publicize the RSA date)  
 July 13\* – tentative date to start Trial Running  
 August 16\*\* - RSAD that we discussed.

\*13 July for Trial Running start is earliest date. OLRTC and RTM may want to use the week of 15 July for "practice" runs and to make sure RTM is ready to take on the Revenue Service support role.

\*\*Committing to the date is important to the City as they need to book drivers/schedules by 17 July for the 3 weeks of parallel bus/LRT service that will start 2<sup>nd</sup> week of September, which is linked to a 16 Aug RSAD.

Best explained in a prep call. I'll leave it to Matt and Gonzalo to organize one prior to the City meeting.
