I agree that a normal brake cut-out should be a relatively straightforward issue and dealt with in the timeframe you stated. Without knowing the actual cause it I difficult to ascertain whether it was a basic troubleshooting problem or serious condition.

All that said, I share your concerns about the readiness of everyone as they move toward revenue service. They won't have the luxury of time and it will be in a "proverbial fishbowl".

Not sure long the train was down for but identifying and isolating a brake(s) is typically a <10 min process. I will follow up with the team tomorrow to see what troubleshooting steps were followed and what issues they encountered trying to overcome the problem.

To be honest I am not confident that our troubleshooting skills and processes are adequate or that we have appropriate guidance (troubleshooting documentation) from Alstom. Troy, we should discuss further this week after I gather some incident specific information
